## 1 Respective responsibilities of the auditor and the authority

Our responsibility as auditors to complete a **limited assurance review** is set out by the National Audit Office (NAO). A limited assurance review is **not a full statutory audit**, it does not constitute an audit carried out in accordance with International Standards on Auditing (UK & Ireland) and hence it **does not** provide the same level of assurance that such an audit would. The UK Government has determined that a lower level of assurance than that provided by a full statutory audit is appropriate for those local public bodies with the lowest levels of spending.

Under a limited assurance review, the auditor is responsible for reviewing Sections 1 and 2 of the Annual Governance and Accountability Return in accordance with NAO Auditor Guidance Note 02 (AGN 02) as issued by the NAO on behalf of the Comptroller and Auditor General. This authority is responsible for ensuring that its financial management is adequate and effective and that it has a sound system of internal control. The authority prepares an Annual Governance and Accountability Return in accordance with *Proper Practices* which:

- confirms and provides assurance on those matters that are relevant to our duties and responsibilities as external auditors.

## 2 External auditor's limited assurance opinion 2024/25

Except for the following matters, on the basis of our review of Sections 1 and 2 of the Annual Governance and Accountability Return (AGAR), in our opinion the information in Sections 1 and 2 of the AGAR is in accordance with Proper Practices and no other matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

Section 1, Assertion 5 has been incorrectly completed. Information received from the smaller authority highlights that risk management arrangements were not reviewed and approved by the authority as a whole during the year. As a result, this assertion should have been answered 'No'. This is consistent with the Internal Auditor's response to Internal Control Objective C

The AGAR was not accurately completed before submission for review. Please ensure that amendments are corrected in the prior year comparatives when completing next year's AGAR.:

• Section 2 Boxes and 6 are incorrectly completed as interbank transfers have been included in the accounts in error. Section 2 Boxes 3 and 6 should read £125,836 and £48,104 respectively.

Other matters not affecting our opinion which we draw to the attention of the authority:

- The AGAR was not accurately completed before submission for review. The AGAR has been amended. Please note that the initialled amendment relates to the prior year Section 2, Box 8 figure and not the Box 9 figure. To clarify Section 2 Box 8 and 9 for the prior year are £397,578 and £79,100 respectively.
- The smaller authority has confirmed that it does not have a signed letter of engagement in place with the internal auditor.
- The smaller authority has not provided year end bank statements for 2 of its bank accounts to support the bank reconciliation. This is
  due to the accounts being fixed term bonds and therefore statements as at 31 March 2025 are not available.
